ARIZONA SCHOOL TAX CREDIT

This year choose to do something really smart about your tax bill..... Keep your money here in Lake Havasu. Tax Credit is a dollar for dollar subtraction from your AZ State Income Tax Liability. You can contribute any time of the year but the deadline for accepting tax credits is April 15th of the following year. You don't have to have a child in the school to benefit from the Tax Credit program.

Arizona Tax Credit gives you a say in how your tax dollars are spent and reduces your tax liability by whatever amount you contribute. When you file your AZ State income tax either subtract the amount of your contribution from what you owe or add the amount to your refund. It is like pre paying your income tax and keeping the money here at Telesisi Preparatory Academy.

The State of Arizona has a law that benefits taxpayers and school children alike. A.R.S. 43-1089 allows a tax credit of \$ 200.00 for individuals or \$ 400.00 for married couples filing jointly, for fees paid to a public school in support of extracurricular activities. 100% of your tax credit dollars will go to Telesisi Preparatory Academy and the extracurricular activity of your choice. **You can designate it for Field Trips, Character Education Club (Lower Level/Junior), Sports & Athletics, Builder's Club, Character Councils (Junior/Academy), Character Education Culture Club, Key Club, National Honor Society/Junior Honor Society/Elementary Honor Society, Student Council (Lower Level), Art Program and Music Program. If you do not have a specific activity to choose, you may select our General Fund.*

Over the last few years, taxpayers like you have helped cover the costs of field trips, admission to plays, museums, nature camps, music, art, character education and many sports programs. The money contributed has made a big impact to our students by giving them the opportunity to participate in these programs.

Tax Credit contributions go directly to our school, not to the State or any other school in the city. Thank you for enhancing education at Telesisi Preparatory Academy.

Please drop off your Tax Credit Form and payment, or mail to Telesisi Preparatory Academy located at 2598 Starlite Lane, Lake Havasu City, AZ 86403.
